Inspector Comments: Observed the following food items holding out of temperature in large cooler underneath cook line:
1.) Approximately 7-10 portioned bags of cooked carne asada(59F) Person in charge stated that this product was cooked a day prior.

Corrected on site. Item was voluntarily discarded and condemned due to improper cooling methods.

2.) Approximately 15-20 cooked chicken breast in stainless steel bin(60-65F) . Person in charge stated this item was cooked thirty minutes prior to inspection. Improper cooling methods observed for this item, person in charge could not properly explain the cooling process at this time.

Corrected on site. This item was placed on ice for rapid cooling.

Ensure potentially hazardous foods are cooled rapidly from 135°F to 70°F within two hours and then cooled from 70°F to 41°F or below for a total of six hours using approved cooling methods. Approved cooling methods include;

1. Placing the food in shallow, heat-conductive pans.
2. Separating the food into smaller or thinner portions.
3. Using rapid cooling equipment such as chill blasters.
4. Adding ice as an ingredient.
5. Using ice paddles.
6. Placing containers in an ice bath, stirring food frequently.
7. In accordance to an approved HACCP Plan.

When placing food in the refrigerator to cool, containers should be loosely covered or uncovered if protected from overhead contamination and to facilitate adequate heat transfer.

When cooling potentially hazardous food in refrigerator leave slightly open to allow heat transfer.

See VC&D for detail.

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

(114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. Inspector Comments: Observed operator was unable to demonstrate the knowledge of minimum temperature of cooking, hot and cold holding for potential hazardous food (PHF) regarding chicken and steak-as it relates to their operation.

Ensure all assigned employees have the knowledge of the required cooking temperatures and the hot and cold holding temperatures of potential hazardous foods.

Minimal cooking time and temperatures:

- Comminuted meat (e.g., ground beef, hamburger, or ground pork), injected meats, and raw shell eggs not cooked per request for immediate service shall be heated to 155°F for 15 seconds.
- Single pieces of beef, lamb, veal, pork, fish, or eggs served for immediate service shall be heated to 145°F for 15 seconds unless otherwise requested by the customer or disclosed.
- Poultry, comminuted poultry (e.g., ground turkey, ground chicken), baluts, and stuffed fish/meat/poultry shall be heated to 165°F for 15 seconds.
- A raw or undercooked whole-muscle intact beef steak may be served or offered for sale in a ready-to-eat form if steak is labeled to indicate it meets the definition of "whole-muscle intact beef" and steak is cooked on top and bottom to a surface temperature of 145°F.

Corrected on site. Employee was educated on this day, also educational handouts were provided to supplement.

Violation Description: All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

Discontinue this practice. Ensure that dispensers are adequately refilled after emptied.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)
