**Inspector Comments:** On this date a complaint investigation was conducted due to complaint (CO0083018) received on April 29, 2022 by San Bernardino County Environmental Health Services.

Reference - HSC

Nature of complaint:

The complainant stated the facility is selling tacos outside on Friday and Saturday nights. They further stated the person making the tacos touches their face and does not wash their hands.

Interview with the manager:

The manager stated they were not aware of the complaint. They however do sell tacos outside of the facility on weekends. The tacos are made by the shared kitchen inside the facility and good hand washing practices are followed.

Observation:

The shared kitchen at the back of the facility was observed to be open. The manager of the shared kitchen stated they do sell tacos outside on the weekends and they are currently in the process of obtaining a health permit. The shared kitchen was told to close until they obtain a valid health permit. They were advised that the health permit will not extend to the outside facility taco stand.

A follow up inspection will be conducted to ensure facility is in compliance. Failure to comply will result in an additional billable reinspection with a 30-minute minimum charge of \$122.50.

No food facility shall conduct activities that are inconsistent with the permit(s) issued by the enforcement agency. (114067(b) & (c), 114381 (a), 114381.2, 114387)
