**Inspector Comments:** The purpose of this visit is to conduct a complaint investigation. A complaint was received by the San Bernardino County Environmental Health Services on September 21, 2022. The complainant stated cockroaches were observed on the floor in the deli kitchen area.

Upon questioning, the operator stated they were not aware of this complaint and have not received any in similar nature. Per operator, the facility receives pest control services every month. Upon further questioning, the operator stated the last time pest control serviced the facility was 09/14/2022, via invoice receipt provided at the time of investigation. During complaint investigation, observed approximately three (3) live nymph cockroaches on the floor underneath the cold holding unit located adjacent to the hand washing sink (See violation 16C023). Observed the live nymph cockroaches to be near critical food preparation areas where open food is stored. Observed a dead adult cockroach located underneath the storage rack located next to the hand washing sink.

Clean and sanitize all affected areas and maintain the facility free from vermin.

A reinspection will be conducted on 09/27/2022 to verify compliance of eliminating vermin/cockroaches from the facility. Failure to comply will result in a billable reinspection of \$122.50 per half hour with a half hour minimum.

Violation(s) observed pose an immediate threat to the public health and safety. The health permit to operate is hereby suspended and facility ordered closed until the listed violation(s) have been corrected and verified by San Bernardino County Public Health Department Environmental Health Services. "Notice of closure" sign posted, do not move, hide, or remove sign.

**Inspector Comments:** Observed approximately three (3) live nymph cockroaches on the floor underneath the cold holding unit located adjacent to the hand wash sink. Note: Observed the live nymph cockroaches to be near critical food preparation areas where open food is stored.

Clean and sanitize all affected areas and maintain the facility free from vermin.

A reinspection will be conducted on 09/27/2022 to verify compliance of eliminating vermin/cockroaches from the facility. Failure to comply will result in a billable reinspection of \$122.50 per half hour with a half hour minimum.

**Violation Description:** Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code.
