POINTS 4	Compliance date not specified	Inspector Comments: Observed the temperature of cooked chickens in hot-holding display case at 109°F. Maintain the hot holding temperature for all foods at or above 135°F. Corrected during inspection by replacing the chickens. Observed the temperature of raw chickens left on prep table at 53°F. Maintain cold food temperatures at 41°F or below. Bring out small amount of food for processing each time. You can, also, use ice to keep the foods during processing on prep table at 41°F, or below. Corrected during inspection by putting the raw chickens into the standing refrigerator.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

POINTS 4	Compliance date not specified	Inspector Comments: Observed no sanitizing solution readily available for use in sanitizing food contact surfaces. Ensure that sanitizing solutions are available in buckets for wiping food contact surfaces. Maintain sanitizing solutions at 100ppm for chlorine and 200ppm for quaternary ammonia. Store wiping cloths in sanitizing solution in buckets prior to and after each use. Corrected during inspection.

POINTS 2	Compliance date not specified	Inspector Comments: Observed no paper towels in the dispenser by the handwashing sink. Ensure that the handwashing sinks are adequately supplied at all times.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

POINTS 1	Compliance date not specified	Inspector Comments: Test strips to check sanitizer level were not available. Provide sanitizer test strips to check strength of sanitizer.

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

POINTS 1	Compliance date not specified	Inspector Comments: Observed wet wiping cloths on counter tops. Place wiping cloths in sanitizing buckets prior to and after each use, or store in other approved storage immediately after each use.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

47. SIGNS POSTED; LAST INSPECTION REPORT AVAILABLE

POINTS 1	Compliance date not specified	Inspector Comments: The last inspection report was not observed on site at time of inspection. Maintain a copy of the current inspection report on site at all times.

Violation Description: Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location. (114381(e)) Letter Grade Placecard shall be properly posted. SBCC 33.1406
