Repair the cold water tap and maintain it in working condition. * Bar soap is still being offered in addition to liquid hand soap at the kitchen handwash sink. bar soap is the only available option at both restrooms' handwash sinks. Immediately discontinue offering bar soap at all handwash sinks. It is unsanitary. Offer only liquid soap from dispensers.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

(114087, 114089, 114089.1(a, b), 114090, 114093.1) Bulk food available for consumer self-service must have an information label, sign, and/or other method of notification that includes the label information. (114089) Prepackaged food must bear a label that complies with the labeling requirements as prescribed by the Sherman Food, Drug and Cosmetic Law. (114089 and 114089(a)) Restaurants must provide a brochure placed at the point of sale that includes at least calories, sodium, saturated fat, and carbohydrates information per menu item. For sit-down restaurants, the information must be provided at the table. Drive-thrus are required to have the brochures available upon request and have a notice of the availability at the point of sale. (114094)

Clean these areas and keep them clean.

Repair the equipment and maintain it in good condition as it was designed and approved. NOTE: These were cited as prior violations.

A proper scoop has a handle which is the only part of the scoop to be touched by unsanitary hands.

Inspector Comments: 1) Observed a leak coming from the waste water plumbing at the kitchen handwash sink.

Repair the plumbing and maintain it in good condition.

2) Observed an inadequate air gap at the ice machine.

Ensure there is at least one (1) inch of vertical air space / gap between the terminal end of the drain line and the overflow rim of the floor sink

3) Observed a non-functional hot water tap at the food preparation sink.

Restore the plumbing as approved and maintain it in good condition.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

Inspector Comments: 1) Observed bare rolls of toilet paper being offered in both restrooms. Both dispensers were observed to be empty.

Discontinue the unsanitary practice of offering toilet paper outside of an approved dispenser. This practice requires that the roll be handled by many unclean hands.

Keep the toilet paper dispenser stocked at all times.

2) Observed a non-functional urinal in the men's restroom.

Repair and maintain in good condition.

Violation Description: Toilet facilities shall be maintained clean, sanitary and in good repair for use by employees and patrons. Toilet rooms shall be separated by a well-fitting, self-closing door. Toilet tissue shall be provided in a permanently installed dispenser at each toilet. Location of toilet facilities used by patrons shall not be located to pass through food preparation, food storage, or utensil washing areas. (114250, 114250.1, 114276)

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
