7. PROPER HOT AND COLD HOLDING TEMPERATURES

Inspector Comments:

Maintain potentially hazardous foods for cold holding at 41F or below.

The following were observed in small egg reach-in next to grill:

1. raw eggs at 52F
2. liquid egg mix at 56F
3. shredded cheese at 53F
4. ham at 45F

It was determined reach-in unit is in disrepair. Liquid eggs were discarded. See VC&D. The ham, cheese and raw eggs were transferred into an alternate refrigeration unit to rapidly chill.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

8. TIME AS A PUBLIC HEALTH CONTROL; PROCEDURES & RECORDS

Inspector Comments:

Ensure potentially hazardous foods labeled as using time as a public health control shall indicate time of preparation and time food shall be discarded. Maintain written procedures on site.

Observed timer not used for cheese and sliced tomatoes which are marked as using time control. Food was said to be brought out in the last 10 minutes.

Violation Description: When time only, rather than time and temperature is used as a public health control, records and documentation must be maintained. Food must be marked or otherwise identified as to what time the food was removed from temperature control. (114000) Food items shall not exceed the time marked. (114000)

Inspector Comments:

Repair small egg reach-in next to grill so that it is capable of holding foods at 41F or below. Discontinue storing potentially hazardous foods inside until repaired.

Observed unit with an ambient temperature of 50F. Potentially hazardous foods stored inside were between 45F-56F (See violation #7).

Clean and maintain dust fan covers in walk-in freezer.

Observed significant dust accumulation.

Repair front coffee reach-in unit.

Observed loose hinges.

Clean and maintain microwave in kitchen area.

Observed significant food debris build-up on microwave ceiling.

Violation Description: All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. (114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114177, 114180, 114182)

Store wet wiping cloths in an approved sanitizer solution between 200 and 400 ppm when using quaternary ammonia.

Observed sanitizer bucket near grill at 100ppm.
 Corrected on site.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

Inspector Comments:

Ensure air curtain at back delivery door remains on during business hours.

Observed off. Corrected on site.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

45. FLOORS, WALLS AND CEILINGS: BUILT, MAINTAINED, AND CLEAN

Clean and maintain floors in walk-in freezer.

Observed food debris accumulation.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

48. FOOD WORKER CERTIFICATION

Observed one employee without a valid food worker card.

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
