<b>POINTS</b> <b>4</b>	Compliance date not specified Complied on 9/18/2015 Violation Reference -	<b>Inspector Comments:</b> Observed the line cook put on gloves, handle raw meat, then remove the gloves and handle trays and wax paper for the cooked product; Employees shall wash their hands when switching between working with raw food and working with ready-to-eat food.

**Violation Description:** Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

<b>POINTS</b> <b>1</b>	Compliance date not specified Not In Compliance Violation Reference - HSC - 114067(f,g), 114099	<b>Inspector Comments:</b> Observed inadequate sanitizer in the wipe down bucket; If used repeatedly, cloths used for cleaning shall be held in a sanitizing solution of an approved concentration (100 ppm available chlorine). Apparently the sanitizer is sitting at the bottom of the wipe down buckets; Stir them well so the sanitizer goes into the entire solution and contacts the wiping cloths.

**Violation Description:** Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.
