**Inspector Comments:** COMPLAINANT EXPLAINS THAT SHE WAS AT THE FACILITY AT 3:00PM ON WEDNESDAY 3/11/15 AND ORDERED COOKIES FROM THE BAKERY AND DRANK A NAKED JUICE FROM THE GROCERY SECTION OF THE STORE. AT APPROXIMATELY 5:00PM ON WEDNESDAY 3/11/15 FIRST SYMPTOMS BEGAN. COMPLAINANT EXPLAINS THAT HER SISTER EXPERIENCED SAME SYMPTOMS.

IN RESPONSE TO THIS COMPLAINT AN INVESTIGATION WAS CONDUCTED TO DETERMINE IF IN FACT THIS ALLEGATION WAS VERIFIABLE. AS A RESULT INSPECTED, THE HANDLING OF BOTH THE COOKIES AND THE NAKED JUICE, AND ASKED MANAGER, CHRIS PAULHAMUS, IF SIMILAR COMPLAINTS WERE REPORTED TO THE FACILITY MANAGEMENT. THE FINDINGS WERE THAT TEMPERATURE AT NAKED JUICE CASE WAS AT 40 DEG F, AND COOKIES ARE NOT POTENTIALLY HAZARDOUS TO WARRANT INVESTIGATION. MOREOVER, MANAGER CHRIS SAID, THEY RARELY RECEIVE COMPLAINTS, BUT ALMOST ALL TO DO WITH QUALITY. PLEASE ENSURE SAFE FOOD IS SERVED AT ALL TIMES.
