Observed that 1 food worker card was expired. Facility has two (2) weeks to submit approved SAN BERNARDINO COUNTY food worker card to EHS or a billable reinspection will occur. **Violation Description:** This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
