Remove the rust or replace the sink with an approved warewash for washing, rinsing and sanitizing of multi use equipment. Contact plan check at 800-442-2283 prior to replacement. Employee unaware of location for sanitizer test kit. Maintain sanitizer test kit readily accessible. If facility lacks a sanitizer test kit , obtain one. (facility currently uses bleach as a santiizer)

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.
