**Inspector Comments:** 1.) Observed multiple adult and nymph german cockroaches crawling on the three compartment sink area.

2.) Observed multiple dead adult german roaches in the walk-in refrigerator.

Manager stated pest control services were completed on 10/14/2020 and 9/15/2020.

Ensure to take effective steps to eliminate roaches from the facility and maintain the facility clear of vermin.

A reinspection will be conducted in 72 hours to determine compliance, to verify roaches are removed completely from the kitchen area.

At this time, facility is closed due to multiple life stages of german roach infestation. Manager stated a pest control service was contacted to provide a service on this day.

**Violation Description:** Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)
