A complaint inspection was conducted on this date in response to complaint number CO0070993.

NATURE OF COMPLAINT:

The complainant alleged that this facility is not complainant with COVID 19 requirements set forth. Complainant alleged that several employees were not observed to be wearing masks, No sanitizing stations provided and no literature guiding customers regarding COVID 19 precautions.

OBSERVATIONS:

Upon arrival, observed numerous employees not wearing masks that were in the process of food preparation and serving. Upon questioning, the manager stated that it gets hot in the facility and they sometimes remove their masks. Observed a hand sanitizer station setup near the mobile pick up station. Observed no COVID 19 literature on the front door which instructs customers to wear masks and practice social distancing. Observed no COVID 19 site plan maintained.

OUTCOME:

The operator was provided information regarding the requirements for operating a food facility during the COVID 19 outbreak. Complaint closed.
