POINTS 2	Compliance date not specified Not In Compliance Violation Reference -	<p>Inspector Comments: Observed cardboard boxes obstructing access to the hand sink at onset of inspection.</p> <p>Discontinue storing items in front of hand sink, maintain sink clear and accessible for handwashing at all times.</p> <p>Ensure all handwashing facilities are free from obstruction and easily accessible.</p>

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

As per operator facility's normal practice is to time stamp these food items and discard within 4-hours.</p> <p>Ensure food is marked or otherwise identified that it has been out of temperature control for less than four hours. All foods under time control shall be discarded after 4 hours.</p> <p>Note: When using time as control only, the following conditions must be met: (1) The food shall be marked or otherwise identified to indicate the time that is four hours past the point in time when the food is removed from temperature control. (2) The food shall be cooked and served, served if ready-to-eat, or discarded within four hours from the point in time when the food is removed from temperature control. (3) The food in unmarked containers or packages or marked to exceed a four-hour limit shall be discarded. (4) Written procedures shall be maintained in the food facility and made available to the enforcement agency upon request.</p>

Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

Repair/maintain leak to prevent possible contamination. Food facilities shall be fully enclosed, kept clean and in good repair. 2) Observed vinyl flooring throughout the facility to be deteriorating with excessive cracks and chips. Repair/maintain flooring in so it is smooth, non absorbent and can facilitate regular maintenance. Ensure that all flooring is in good repair and easily cleanable.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
