Discontinue all open food activities. Sanitizer solution shall be available at the facility at all time. All food-contact surfaces of utensils and equipment shall be cleaned and sanitized. Note: The manager instructed the employee to remove the self-service jerky (2 containers) from the front counter. A follow-up inspection will be conducted on 6/30/21 to verify compliance regarding approved sanitizer availability. Observed no hot water at the following sinks: 3-compartment sink, janitorial sink, hand sink located in the employee restroom. Discontinue all open food activities. An adequate, pressurized supply of hot water shall be provided at a minimum temperature of 120°F when measured from the faucet and an adequate, pressurized supply of cold water shall be provided. Note: The manager instructed the employee to remove the self-service jerky (2 containers) from the front counter. A follow-up inspection will be conducted on 6/30/21 to verify compliance regarding the hot water supply. If compliance is not met upon reinspection, then a billable re-inspection will follow.

Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Testing equipment and materials shall be provided to measure the applicable sanitization method. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

(114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. Complete and return the completed handout and copies of all cards/certifications to San Bernardino County Environmental Health Services by email to sbcfoodworker@gmail.com or via mail or fax to 909-387-4323.

Fail to comply 100% will result in a charged inspection of \$122.50 minimum to verify compliance.

After this date, if these employees might no longer be working at this facility, person in charge shall clearly indicate the dates of termination onto the Missing Food Handler Cards- Inspector Handouts.

Violation Description: This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code [Schedule of Fees](#). Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
