Violation Description: Violation(s) observed pose an immediate threat to public health and safety and the health permit to operate is hereby suspended and ordered closed until the listed violation(s) have been corrected and verified by DEHS. Facility is to remain closed until permission from DEHS is given. Contact your inspector at your local office to schedule a reinspection to reinstate the health permit. Posted closed, do not move, hide, or remove sign.

Inspector Comments: Observed german cockroaches in the kitchen area (one nymph, one adult) and one juvenile in a utility closet.

Not In Compliance

Violation Reference - HSC - 114259.1, 114259.4, 11425

Ensure the facility is free of cockroaches. Clean all food preparation surfaces and utensils.

Owner instructed on the need to attend a meeting with Public Health supervision on 6/15/18.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Overall Inspection Comments

Our office received a complaint of multiple cockroach sighting. The complaint alleged that several nymphs were observed on the front service counter top. Adult forms were observed in the restroom.

Observations:

After introductions and explaining the nature of the complaint to the acting manager, an inspection was made of the facility.

German cockroaches were observed in the following areas: 1) one nymphal form and one adult were observed under and around the soda dispenser behind the service counter; 2) one juvenile form was observed in a utility closet next to the restrooms.

After consulting with Public Health supervision, the facility was closed. The owner was instructed to have a pest control service treat the facility, sanitize all food preparation surfaces and call the Department as soon as this has been completed for a reinspection before 10:00 am on 6/15/18.

The owner was also informed that he would need to attend a supervisory review on 6/15/18. Contact information was left with the owner.
