(113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. Inspector Comments: Observed no internal thermometer within the small reach-in cooler unit located behind the sandwich prep area. Provide accurate internal thermometers for each refrigeration unit throughout facility.

Violation Description: An accurate easily readable metal probe thermometer suitable for measuring temperature of food shall be available to the food handler. A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)

Inspector Comments: Observed no air gap between drain pipe of prep sink and rim of floor sink. Ensure that all equipment pipes discharging waste into a floor sink have an air gap at least 1 inch to prevent any potential backflow contamination issues.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

Inspector Comments: Observed (5) employees working within this facility without valid San Bernardino County food worker cards on site. Ensure that all employees obtain a valid San Bernardino County Food Worker Card within 14 days of this inspection. Failure to provide our office with proof of compliance within 14 business days will result in a charged inspection billed at a rate of \$245 per hour with a 30-minute minimum or other further action. Violation Description: This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044).
