Inspector Comments: Permit for open food sales is suspended due to cockroach activity. Prepackaged food sales may continue.

Violation Description: If an imminent health hazard is found, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed. (114409, 114405)

16K023 No rodents, insects, birds, or animals

Inspector Comments: Observed both live and dead German cockroaches in the following areas:

- * Approximately ten dead adult roaches and nymphs on the floor and cabinetry throughout the kitchen and back storage area.
- * One live adult adult on the counter top next to the "Cheese and Chili Sauce" dispenser.
- * One live adult on the stainless steel kitchen counter top.

Immediately cease the sale and preparation of open food. The sale of prepackaged food may continue. Open food sale may resume ones a reinspection by our office confirms the roaches have been eliminated.

Immediately eradicate the cockroach infestation. Sanitize all food contact surfaces once the roaches have been controlled.

The facility's management must attend a supervisory review to discuss plans to eradicate the current infestation and how its recurrence in the future. The meeting is scheduled for 3:00 pm on October 10, 2018. The address is 385 N. Arrowhead Ave., San Bernardino. The phone number is 1-800-442-2283.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Overall Inspection Comments

Open food sales are suspended due to German cockroach infestation. Only prepackaged food sales are allowed.

Supervisory review scheduled for October 10, 2018 at 3:00 pm.
