Inspector Comments: A re-reinspection was conducted on this date to verify clean-up of the floor in the back storage room with rodent droppings. This storage room contained racks with cleaning chemicals and was located near the back door, which was screened.

A reinspection on 9/16/20 was conducted to verify repair of the automatic dishwasher as well as clean-up of the area in the back storage room with rodent droppings. On that date, the automatic dishwasher was repaired, but the rodent droppings had not been cleaned up.

On this date, the following was observed:

- 1. In the back storage room containing cleaning chemicals, the floor had been noticeably cleaned. Old rodent droppings were gone, however, approximately 10 new fresh rodent droppings were observed on the floor under the storage racks. The back door with a screen is next to this storage room. No large gaps were noted around the screen door. Weatherstripping was present along the bottom. There was a metal strip and the lower part was a mesh-like material.
- 2. In the back dry storage room, containing paper goods, dry bulk food and canned goods, approximately 10 fresh rodent droppings observed on two stacks of wrapped paper towels; 11 rodent droppings on the floor under the racks; one rodent dropping on wrapped toilet paper.
- 3. Under the automatic dishwasher, the base coving has fallen off the wall along approximately 3-4 ft of the wall. Two holes were observed in the wall behind where the base coving had been. One hole, on the left side, was shaped like a triangle and measured about 3 inches x 3 inches x 5 inches. The other hole, on the right side, was larger, approximately the size of two base coving tiles. A rodent metal box trap and a glue board were noted on top of the rubble of the broken base coving. Approximately 30 rodent droppings were observed in this area.
- 4. In the customer area near the public restrooms, approximately 20 rodent droppings along the wall behind a tall wooden cabinet and approximately 6 droppings behind a stuffed chair.
- 5. In the customer dining area, approximately 3 rodent droppings in the northwest corner, approximately 5 rodent droppings in the northeast corner.
- 6. In the storage area across from the public restrooms, about 3 rodent droppings on the floor.
- 7. Manager stated Orkin Pest Control comes about once a month, however, no pest control receipts were available for review.

Eliminate vermin and evidence of vermin from the facility. Repair the holes in the wall, repair/replace the base coving.

Note: The owner was contacted by phone. Pest control receipts requested to be emailed. Owner informed pest control shall be scheduled for the following day. A reinspection will be conducted in 24 hours to verify removal of the rodent droppings. All surfaces in contact with rodent droppings shall be cleaned and sanitized.

Description: Billable re-reinspection conducted at this time to determine compliance from prior reinspection.
