- One small live cockroach on the panel below reach in refrigerator storing alcoholic beverage.
- Two small live cockroaches in the aisle where prepackaged items are sold.
- Several dead large cockroaches next to floor sink near unused ice machine.
- Pest control receipt dated 9/30.

Health permit is to remain suspended and only allowed to offer for sale prepackaged items.
