POINTS 4	Compliance date not specified Complied on 4/12/2019 Violation Reference - HSC - 113996, 113998, 114037	Inspector Comments: Observed multiple pans filled with cooked pasta, lasagna, and eggplant to be stored on top of the reach in refrigerator in the kitchen which measured at temperature ranges of 73-103 degrees fahrenheit (F). Cook stated the items were cooked 3 hours prior to temperature measurement. Immediately reheat all items stated above to a minimum of 165 degrees F within 1 hour. Ensure all potentially hazardous foods (PHF) are cold holding at 41 degrees F or below or hot holding at 135 degrees F or above.

A reinspection will be conducted to verify compliance. Failure to comply will result in a billable re-inspection.

Educated cook that the minimum internal cooking temperature of chicken shall be 165 degrees F.

9. PROPER COOLING METHODS

Inspector Comments: Observed a covered pan of eggplant parmesan to be cooling inside the reach in refrigerator on the cooks line which measured at 122 degrees fahrenheit (F). Cook stated it was cooked 1 hour prior to temperature measurement.

Ensure potentially hazardous foods are cooled rapidly from 135°F to 70°F within two hours and then cooled from 70°F to 41°F within the next four hours using approved cooling methods.

Approved cooling methods include;

1. Placing the food in shallow, heat-conductive pans.
2. Separating the food into smaller or thinner portions.
3. Using rapid cooling equipment such as chill blasters.
4. Adding ice as an ingredient.
5. Using ice paddles.
6. Placing containers in an ice bath, stirring food frequently.
7. In accordance to an approved HACCP Plan

When placing food in the refrigerator to cool, containers should be loosely covered or uncovered if protected from overhead contamination, to facilitate heat transfer from the surface of the food.

11. Reheating

Instructed cook to immediately begin the cooling process and monitor time and temperature.

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))
