

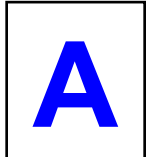

Contact Environmental Health Services at 1-800-442-2283 to schedule reinspection once vermin infestation has been eliminated prior to opening for operation.

POINTS 4	Compliance date not specified Not In Compliance Violation Reference - HSC - 114259.1, 114259.4, 11425	Inspector Comments: Observed live and dead cockroaches of all life cycles in different areas throughout facility, including in cabinet beneath handwash sink, on floors and walls beneath warewashing sink, on shelving containing clean bins/utensils, and on clean stored bins. Approximately seven egg casings observed on floor beneath ice machine. Obtain a form of pest control to eliminate and maintain facility free from cockroaches at all times. Due active cockroach infestation, facility is closed and permit suspended until reinspection is conducted to verify elimination of infestation. Ensure to clean and sanitize all contaminated areas including, bins, utensils and shelving. Seal all holes, cracks and gaps from floors, walls and ceilings to eliminate points of entry for vermin. Note: Operator stated pest control services facility, with most recent visit one week prior to inspection.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

40. WIPING CLOTHS: PROPERLY USED AND STORED

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114135, 114185.1	Inspector Comments: 1) Observed wet wiping cloth store on counter adjacent to drive through window. Ensure wiping cloth are stored in sanitizer solution in between uses. 2) Observed sanitizer solution of quaternary ammonium at approximately 100ppm. Ensure to maintain a minimum concentration of 200pm for quaternary ammonium.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

44. PREMISES; PERSONAL/CLEANING ITEMS; VERMIN-PROOFING

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114067 (j), 114123	Inspector Comments: 1) Observed two fly sticky traps hanging from ceiling in food prep area. Discontinue use of unapproved vermin proofing methods, and use approved method such as uv light or air curtain. 2) Observed numerous personal items stored on shelf commingled with food intended for customer consumption. Designate area for employee personal items away from food intended for costumers.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

IMPORTANT: Risk Based Inspection Frequency

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code [Schedule of Fees](#). Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
