Inspector Comments: Per owner's request a re-inspection was conducted on this date to determine compliance with a critical violation observed at the last inspection. Noted on the last inspection report, inspector observed facility to have an active cockroach infestation.

At the time of re-inspection the following was observed:

- One (1) dead adult cockroach behind pepsi reach refrigerator on the sales floor (see violation 16k994)
- Flies were observed in the produce and meat handling areas (see violation 16k994)
- Old rodent droppings in crevices/ floor underneath meat display case (see violation 16k994)

As per owner last pest control service was conducted by ANTMART Pest Management on 7/13/18, manifest/report was not provided. Ensure to provide such documentation to this department within 24-hours, confirming no vermin activity. Highly recommended to continue with receiving regular pest control treatment.

No signs of an active vermin infestation were observed on this date.

Description: Reinspection conducted at this time to determine compliance from prior inspection.

Clean/sanitize affected areas.

Ensure to maintain facility free of vermin at all times

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)
