Inspector Comments: 1. Upon questioning, a food worker stated that the utensils are washed and sanitized every two (2) to three (3) days when business is slow.

Ensure that person in charge (PIC) and/or food employees are able to demonstrate food safety knowledge practices and principles applicable to their assigned duties.

Ensure that utensils used to handle potentially hazardous foods (PHFs) are washed at least every four (4) hours, or as necessary.

2. Observed no current Certified Food Manager's Certificate available during the inspection.

Obtain at least one (1) Certified Food Manager's certificate from one of the accredited organization that has been certified by the American National Standards Institute (ANSI):

Ensure that handwash sinks are able to supply hot water of at least 100F and cold water at all times.

Corrected on site. The manager repaired the handwash sink and it was observed providing cold water.

Inspector Comments: Observed a bucket of wastewater stored on the floor next to the three (3) compartment sink. Upon questioning, a food worker stated that the wastewater from warewashing is put in the bucket and used to water plants outside the facility.

Discontinue this practice. Ensure that wastewater is disposed of through an approved plumbing system or discharges into the public sewer system or an approved private disposal system.

Violation Description: All liquid waste must drain to an approved fully functioning sewage disposal system. (114197) Toilet facilities must be operable.

2. Observed five (5) dead cockroaches on the floor of the supply closet in the back kitchen area.

Clean these areas and maintain the facility free of vermin.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields.
