POINTS 2	Compliance date not specified Not In Compliance Violation Reference -	Inspector Comments: Observed that the soap dispenser in the produce dept was behind boxes and not accessible. Relocate soap dispenser near the sink so it can be used.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

14. FOOD CONTACT SURFACES: CLEAN AND SANITIZED

POINTS 2	Compliance date not specified Not In Compliance Violation Reference - HSC - 113984(e), 114097, 114099	Inspector Comments: Observed that employee in the produce dept was not properly washing and sanitizing the knives. All equipment must be washed in hot (100F) water with soap, rinsed, soaked in sanitizer and air dried. If using chlorine, concentration must be 100ppm for 30 seconds. If using quaternary ammonia, concentration must be 200ppm for 1 minute. Still observed that the two compartment sink in the produce dept does not hold water as noted on prior inspection reports. Replace sink levers.

Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose.
