**5. HANDS CLEAN AND PROPERLY WASHED; GLOVES USED PROPERLY** **⚠ CRITICAL ⚠**

<b>POINTS</b> <b>4</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed employee wiping hands on apron, then began to prep food. Discontinue drying hands on apron, ensure hand washing is properly done at hand washing sink with warm water (at least 100 deg F) and soap and dried using paper towel.  Observed employee in bar area squeezing sliced lemons with acrylic nails into a drink. Ensure employees with acrylic nails use a barrier (thongs or gloves) when handling food items to prevent contamination .

**Violation Description:** Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed that access to the handwashing sink was obstructed by a trash can in food prep area. Ensure handwash sinks are easily accessible at all times.  Observed no paper towel dispenser in bar area. Observed no soap/soap dispenser in bar area. Ensure handwash sink is fully stocked with soap and paper towels in a dispenser.  Observed no soap in dispenser(had dishwashing soap squeeze bottle) in food prep area. Ensure handwash sink is fully stocked at all times; pump soap bottles may be used.

**Violation Description:** Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

**30. FOOD STORAGE; FOOD STORAGE CONTAINERS IDENTIFIED**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed boxes of peanuts, a box of potatoes and a bag of pop corn on floor in storage area. Observed beef boxed stored on the floor in the walk-in cooler. Ensure to store all food items at least 6 inches off the floor, to protect from contamination.  Observed open bags of dried bread crumbs (panko) in storage area. Ensure that all bulk foods, or foods in non-resealable packaging, are transferred into an approved container with a tightly fitting lid with a label after opening.  Observed unlabeled dry good bulk containers of food in storage area. Ensure to label all containers with the common name of the food.

**Violation Description:** Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

**38. ADEQUATE VENTILATION AND LIGHTING; DESIGNATED AREA**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b>  Observed grease build up on hood filters at cooks line. Maintain cook line hood filters clean to provide adequate ventilation.

**Violation Description:** Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. **41. PLUMBING; PROPER BACKFLOW DEVICES**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b>  Observed insufficient air gap between draining pipe and floor sink, next to mop sink and in floor sink next to the ice machine (one of the two pipes in this location). Ensure to have an air gap of at least one inch or twice the diameter of the draining pipe, whichever is greater.  Observed leaking pipe underneath 3-compartment sink in food prep area. Repair/replace

**Violation Description:** The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. Ensure to store employee clothes in a separate designated area, apart from retail food items.  Observed a cup of water with ice and straw on shelf in front of 3 compartment sink. Ensure to store employee drinks/food items in a separate, designated area apart from retail food items.

**Violation Description:** The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. **Violation Description:** The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
