-Two (2) live cockroaches in dining room area.  
-Multiple dead cockroaches throughout the kitchen.

Ensure vermin problem is abated IMMEDIATELY. Thoroughly clean and sanitize facility.

**Violation Description:** Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

#### Overall Inspection Comments

This re-inspection was conducted in response to a complaint investigation where a cockroach infestation was observed on 7/28/16.
