

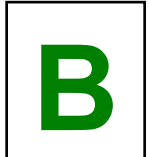

Do not use the preparation sink to wash plates. Ensure 3-compartment sink is being used to clean plates to properly wash, rinse, sanitize and air-dry.</p>

Ensure raw food items are stored below from ready-to-eat food items to prevent possible contamination.</p> <p>2. Observed a rusty power outlet hanging above a preparation table next to walk-in refrigerator. Note: No preparation was observed at the time of the inspection.</p> <p>Ensure food is prepared in an area where contamination cannot occur.</p>

Store all scoops so that the handle does not come in contact with food. 3. Observed clean containers stored on shelf that is accumulated with grease and dust next to 3-compartment sink. The containers were not observed in use. Ensure all food contact surfaces are stored so that they are protected from contamination. Clean and sanitize the containers prior to use.

Provide the missing light shield. 2. Observed accumulation of grease on ventilation filter above stove for meat. Clean and sanitize the ventilation system as often as necessary to prevent dripping of grease onto food or fire. 3. Observed gaps in ventilation filters. Ensure ventilation filters are installed properly without gaps.

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. Towels were observed stored in the bucket. The towels were not observed in use. Maintain the concentration of chlorine sanitizer at a minimum of 100 ppm when in use.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

POINTS 3	Compliance date not specified Not In Compliance Violation Reference - SBCC - 33.0409	<p>Inspector Comments: Observed four food handler cards invalid or missing. Per person in charge, these employees began employment more than 2 weeks prior to the inspection.</p> <p>Ensure all food handlers obtain valid food handler certificates within fourteen (14) days of employment. A missing food handler cards-inspector handout was provided to fill out. Email the completed handout and copies of valid San Bernardino County food handler card to sbcfoodworker@gmail.com within 14 days. Failure to comply shall result in unannounced billable follow up inspection at an hourly rate of \$245 with 30-minute minimum.</p>

Violation Description: This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code [Schedule of Fees](#). Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
