Inspector Comments: Observed the temperature of food items in the reach-in refrigerator at 56°F for cooked chicken, 58°F for sliced beef and 55°F for meatballs. Maintain cold food temperatures at 41°F or below. Keep all cold foods inside the walk-in refrigerator until the reach-in refrigeration is repaired. You can, also, use ice during the repair period to keep the foods at 41°F, or below. Corrected during inspection by putting the perishable foods into the walk-in refrigerator.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Inspector Comments: Observed no sanitizing solution readily available for use in sanitizing food contact surfaces. None of the employees knew that certain measured amount of sanitizer is required. Went over the procedure with the employees.

Violation Description: All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

Inspector Comments: Observed no sanitizing solution readily available for use in sanitizing food contact surfaces. Ensure that sanitizing solutions are available in buckets for wiping food contact surfaces. Maintain sanitizing solutions at 100ppm for chlorine and 200ppm for quaternary ammonia. Store wiping cloths in sanitizing solution in buckets prior to and after each use. Corrected during inspection.

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

Violation Description: Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location.
