16K999 Complaint Inspection

Compliance Date: Not Specified	Inspector Comments: A complaint inspection was conducted on this date 10/15/2021 based on a complaint received by Environmental Health Services. Complaint stated that facility was operating without any hot water.
Reference - HSC	Upon arrival at facility supervisor was spoken too and stated that they do not have hot water in the facility and that the facility has been using the hot water boiler dispenser to fill containers to bring to the back room to wash dishes. When asked about the hand washing sinks supervisor stated hand washing sinks do not have hot water either. Sinks were checked and maximum water temperature observed was 73F. Facility Manager was also spoken too and stated that they have had a broken booster system since last month. Emails were provided showing an attempted repair date of 9/9/2021 but Manager stated that they were not able to repair the system.
	Based on observations made, facility was instructed to immediately discontinue service and facility was posted closed. Facility Health Permit has also been suspended due to lack of hot water in facility. Facility began discarded all open food products that had been prepared. Facility was allowed to keep any sealed or prepackaged products as well as whole unused produce. Facility manager stated they will be bringing unused produce to other food facilities on campus for storage.
	Food Facilities Administrator was spoken to after closure and was instructed to provide the following information to Environmental Health Services:
	 Specifications for Einstein Bagel's Hot Water Heater including Brand, Model Number, and Data Plate. Specifications for Booster system used in Einstein Bagels that supplies water to the facility.
	Booster System specifications originally provided to Environmental Health Services list an AO Smith Model SU-20 system with a 20 Gallon Capacity and 9 KW input rating. If facility is to replace booster system, equipment must be replaced like-for-like or if a new system is to be installed specifications must be provided to Environmental Health Services prior to installation.

Description: A complaint report has been received by Environmental Health.
