POINTS 4	Compliance date not specified Complied on 7/28/2015 Violation Reference - HSC - 113996, 113998, 114037	Inspector Comments: Observed large plastic container of pork in cook line reach in refrigerator at 47F. Observed small plastic container of chicken in cook line reach in refrigerator at 53F. Cook stated that chicken and pork were prepared one day prior. Corrected on site. Food was voluntarily discarded. Ensure to maintain cold holding foods at 41F and below.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

POINTS 2	Compliance date not specified Complied on 7/28/2015 Violation Reference -	Inspector Comments: Observed hand-wash sink blocked by push cart. Corrected on site. Push cart was moved to ensure hand-wash sink was accessible. Ensure to maintain hand-wash stations throughout facility clear and accessible.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

36. EQUIPMENT, UTENSILS AND LINENS: STORAGE AND USE

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114074, 114081, 114119	Inspector Comments: Observed 1 sofa, 1 prep table, 2 ice machines, and 1 fridge next to downstairs trash area. PIC stated that items are waiting to be picked up. Ensure to discard of these units/pieces of furniture as soon as possible to avoid pest harborage.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

42. GARBAGE AND REFUSE PROPERLY DISPOSED; FACILITIES MAINTAINED

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114244, 114245	Inspector Comments: Observed excessive trash build-up of boxes next to trash area. PIC stated that they do not have a trash bin for recyclables. Ensure to obtain additional trash bins with lids to avoid excessive trash build up and pest harborage.

Violation Description: All food waste and rubbish shall be kept in leak proof and rodent proof containers. Containers shall be covered at all times. All waste must be removed and disposed of as frequently as necessary to prevent a nuisance. The exterior premises of each food facility shall be kept clean and free of litter and rubbish. (114244, 114245, 114245.1, 114245.2, 114245.3, 114245.4, 114245.5, 114245.6, 114245.7, 114245.8)

POINTS 1	Compliance date not specified	Inspector Comments: Observed front door open upon arrival and throughout inspection. Observed downstairs door propped open. Observed 2 inch cracks in screen at bottom and top of back door. In order to prevent cockroaches, flies and other vermin from entering the facility, cease from propping the door open. Repair back screen as soon as possible.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)
