Ensure paper towels are always stocked in dispenser. Observed cashiers hand wash sink obstructed by boxes. Ensure hand wash sink is always accessible.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Corrective action: Ecolab has been called for service and out of order sign has been placed in machine. Employees are to manually wash dishes in 3 compartment sink.
