Inspector Comments: On this date a follow up inspection was conducted to verify that the following have been corrected:

- The beverage air refrigerator is functioning properly.
- Hot water available at the multigender restroom located on wall facing the cash registers.

Observation(s):

- Observed empty beverage air refrigerator. Manager stated that the unit is missing a part.
- Measured hot water at 110 F in the multigender restroom.
- Grade card to have been removed from original location (next to the main entrance door) posted by inspector.
- Grade card to be inside frame at the front counter. Grade card must be posted in a visible location for all customers including drive thru customers.

Conclusion(s):

- Ensure the beverage air refrigerator is repaired.
- An additional billable follow up inspection will be conducted to verify that the beverage air unit is functioning properly.
- DO NOT REMOVE, RELOCATE, OR MOVE GRADE CARD. FAILURE TO COMPLY MAY RESULT IN A BILLABLE REINSPECTION.
