Inspector Comments: The purpose of this follow-up was conducted per operators request.

On 10/1/20 this facility was closed during a routine inspection due to an imminent health hazard. Several live and dead nymph and adult German cockroaches were observed in the coffee preparation area and

storage cabinet of this facility.

On this date person in charge stated facility had been cleaned and sanitized. She stated that a professional exterminator treated the facility.

Pest control reports were provided.

Facility was observed clean and sanitized. No observations of live or dead roaches were present on this date.

Upon arrival facility was observed closed.

The health permit for this facility has been reinstated, this facility may now operate.

A one-week reinspection will be conducted to verify facility continues free of vermin activity. Failure to comply will result in a billable reinspection.

Description: Billable re-reinspection conducted at this time to determine compliance from prior reinspection.

#### **Overall Inspection Comments**

"Notice of closure" sign removed.

Letter grade "B" posted on this date.

Do not relocate or remove the grade card. Do not cover up, obscure, deface, mar, or camouflage the grade card. Failure to comply will result in a charged inspection at an hourly rate of \$245.

For a B grade (score of 80 to 89) A re-score inspection may be requested by a food facility who receives a "B" grade after the completion of an official routine inspection. This request is optional on the part of the facility which may wish to try to improve their score or letter grade. The Health Official will complete the re-score inspection within ten (10) County business days of the food facility submitting a request for a re-score inspection. The inspection rate is \$245.00 per hour. A minimum of \$122.50 will be charged for the first 30 minutes of inspection time.

A Letter Grade Card shall remain valid until the Health Official completes the next routine inspection or re-score inspection of the food facility. A re-score inspection is a new, unscheduled, complete routine inspection that a)may be required by County Ordinance; or b) may be requested by the food facility.
