According to manager, chicken wings are cooked and stored in cooler drawer for seventy-two (72) hours prior to being discarded. Upon questioning, manager stated it is unknown when chicken wings were prepared observed at 43F were prepared versus when chicken wings observed at 110F were prepared. Labels indicating prep and discarded items missing from bone-in chicken wing bin.</p> <p>Discontinue commingling chicken wings that are cooked at separate times, and provide proper labels indicating seventy-two (72) hours time for discard.</p> <p>During inspection, chicken wings were discarded by manager. See VC&D.</p>
