9. PROPER COOLING METHODS

POINTS 2	Compliance date not specified Not In Compliance Violation Reference - HSC - 114000	Inspector Comments: Observed 3 types of salsa cooling in ice bath. Temperature of salsas observed at 72 -78 F, no cooling logs observed. Per the cook, product had been in ice bath with ice added to the product for approximately 15 minutes. Provide a method to verify proper cooling procedures.

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

11. PROPER REHEATING PROCEDURES FOR HOT HOLDING



POINTS 4	Compliance date not specified Complied on 7/27/2016 Violation Reference - HSC - 114014, 114016	Inspector Comments: Observed rice cooked on grill before putting in hot holding unit to a temperature between 140 F and 159 F. Observed that the Cook, the food safety manager certificate holder, did not take the temperature of the rice prior to placing in warmer. Foods must be re-heated to 165F before placing in the hot holding unit. Corrected on site.

Violation Description: Any potentially hazardous foods cooked, cooled and subsequently reheated for hot holding or serving must be brought to an internal temperature of 165F for 15 seconds within 2 hours. (114014, 114016) PHF's reheated in a microwave to 165 F for 15 seconds must be rotated or stirred, covered, and allowed to stand covered for two minutes after reheating.
