Not In Compliance Reference - HSC **Inspector Comments:** The facility was treated for cockroaches on October 12, 2018 by "Clark Pest Control". Invoice 23420735 was produced as documentation stating that the facility had been treated with dinoterfuran and fipronil gel bait.

No live cockroaches were observed. Two dead roaches were observed on the sales room floor but were removed by management during the reinspection.

The odor of bleach was obvious in the kitchen area. Management stated that all food contact surfaces hand been sanitized with bleach.

Permit reinstated to sell open food. "Notice of Closure" sign removed.

Complaint closed.

Description: The health permit to operate is hereby reinstated and facility may open.
