<b>POINTS</b> <b>4</b>	Compliance date not specified Complied on <b>4/24/2015</b> Violation Reference - HSC - <b>114000</b>	<b>Inspector Comments:</b> Measured vegetable soup in a deep, covered plastic container in a refrigerator at 48 - 49 F. The soup was cooked on previous day.  Ensure to cool food rapidly from 135 F to 70 F within 2 hours and from 70 F to 41 F within 4 hours. Use shallow stainless steel container (not to exceed 2" high), ice bath or ice paddle.  The food may be transferred to another container with lid once it is cooled down to 41 F.

**Violation Description:** All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

(114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

**40. WIPING CLOTHS: PROPERLY USED AND STORED**
