Observed buildup within ice machine without indication that ice was adulterated. Clean and maintain ice machine on a more frequent basis. Observed food debris on ice scoop. Properly clean and sanitize ice scoop. Scoop cleaned and sanitized immediately.

Store wiping towels in either 200-300 ppm quaternary ammonia or 100-200 ppm chlorine.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

Replacement part for faucet has been placed on special order per operator.

Observed no air gap between drainpipe at bar jockey.
Maintain an air gap of at least 1 inch between wastewater pipe and floor sink to prevent back siphonage.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof.
