Inspector Comments: The purpose of this visit was to conduct a follow-up inspection regarding a cockroach infestation.

FINDING(S):

The owner stated the following:

- Has not seen any live cockroaches this week, only dead cockroaches.
- Inspects for cockroaches and cleans the facility every morning and as needed throughout the day.
- Provided pest control services on 9/3/19.
- Invoice of pest control services available upon request.
- Pest control services will be provided in one (1) week from 9/3/19.

OBSERVATION(S):

- Dead cockroach under the upright freezer by the employee entrance.
- Dead cockroach in the dry storage room.
- Dead cockroach under the 2-compartment sink.
- Dead cockroach under the mechanical warewashing machine.
- Two (2) cockroaches under the storage rack across from the mechanical warewashing machine.
- Dead cockroach in the hallway outside the women's restroom.
- No live cockroaches anywhere in the facility at this time.
- No dead or live cockroaches in the seating area.
- Provided invoice of pest control services (9/3/19) upon request.

RESULT(S):

Complaint closed on this date.
