POINTS 4	<p>Compliance date not specified Not In Compliance Violation Reference - HSC - 113984(e), 114097, 114099</p>	<p>Inspector Comments: Observed mechanical dishwasher at 10 ppm chlorine sanitizer. Facility had no supply of chlorine sanitizer for the dishwasher available.</p> <p>Discontinue use of mechanical dishwasher until supply of chlorine sanitizer is replenished and tested for 50 ppm. In the interim, manual washing in the three compartment sink to be done for all glassware, dishes and utensils in the following manner:</p> <ol style="list-style-type: none"> 1. In the first sink: Wash items in warm water (100°F) and detergent. 2. In the second sink: Rinse in clear water. 3. In the third sink: Sanitize items in sanitizing solution: 100 ppm chlorine solution for at least 30 seconds or 200 ppm quaternary ammonium solution for at least one minute. 4. Finally, air dry all items on the drain board closest to the sink used for sanitizing. <p>A reinspection will be done in 72 hours to verify compliance for automatic dishwasher.</p>

Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

Ensure wet wiping cloths are stored submerged in sanitizer solution when not in use. 2. Observed chlorine sanitizer concentration in sanitizer bucket measuring 10 ppm. Maintain chlorine sanitizer solution above 100 ppm.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

(114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. Toilet tissue shall be provided in a permanently installed dispenser at each toilet. - Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
