2) Observed dead/live flies in the following areas:

- On sales floor of below pre-packaged chips and bread
- Among produce shelving units
- Approximately 10-15 dead flies on shelving of Coca cola Machine.
- Approximately 3-5 dead flies on shelving unit of Knudsen Milk reach in refrigeration unit

Eliminate vermin from the facility. Clean and sanitize all affected areas.

A re-inspection will be conducted at a later date to determine compliance.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)
