The operator stated the pest control company was here today and conducted service of the facility. The operator provided a copy of the report that was conducted on this date. A supervisory review is scheduled for tomorrow at 9:30 in the Rancho Cucamonga office located at 8575 Haven ave, Rancho Cucamonga 91730. Provide pest control reports/ receipts to this review. Continue conducting proper exclusion methods to eliminate the cockroach infestation. Seal/ patching any openings on the floors, walls and ceilings. Clean and sanitize all affected areas. Eliminate all vermin and evidence of vermin from this facility including but not limited to cockroaches.

Note-The Health Permit was suspended this date due to the cockroach infestation in this food facility.

**Violation Description:** Violation(s) observed pose an immediate threat to public health and safety and the health permit to operate is hereby suspended and ordered closed until the listed violation(s) have been corrected and verified by DEHS.
