Dear Homeowner:

Enclosed is a "Uniform Handling Exemption Request" for July 1, 2012 through June 30, 2013. In order to qualify for an exemption, you must submit three (3) sets of four (4) consecutive weekly disposal receipts from a County-owned landfill or transfer station along with the completed application and fees to the Solid Waste Management Division (SWMD). Fees include a \$15.00 *non-refundable* processing fee and \$85.14 for a *San Bernardino County Disposal Use Permit*.

Exemption requests received on or before June 30, 2012, will be effective on July 1, 2012. Exemption requests received after June 30, 2012 will not be effective until the first date of the next billing cycle. For example, applications received between July 1, 2012 and September 30, 2012 will be effective October 1, 2012.

Fee Waiver Program

Properties that are primarily vacant may be eligible for a fee waiver if the average daily energy usage at the property is at or below 6 kilowatt-hours per day (April through November) and 10 kilowatt-hours (December through March). Owners that wish to be considered for a fee waiver can submit electricity bills for the most recent 3-month period for the property to your local hauler. Once eligibility is confirmed, your local hauler will apply a credit to the account for that quarter of trash service. For more information please contact your local hauler (see page two).
