

## Section 1. WHEREAS:

- (a) an application dated October 30, 2002 was considered by the Local Agency Formation Commission of Kern County ("Commission") for City of California City Reorganization No. 2 designated as Proceeding No. 1348, the exterior boundaries of which are described in Exhibit "A", attached hereto and incorporated herein by this reference; and
- (b) a dully noted noticed public hearing upon said proposal was held before the Commission on February 25, 2003; and
- (c) following said public hearing the Commission, on February 25, 2003 adopted its Resolution Making Determination , being Resolution No. 03-05 recorded in Minute book 50 of said Commission said Resolution is attached here to as Exhibit "C" and is incorporated herein say this reference; and
- (d) after duly mailed and published notice, the Executive Officer of LAFCo set Friday, April 11, 2003 at the hour of 1:00 p.m. (or as soon thereafter as the matter may be heard) in the first floor conference room of the Public Service Building in Bakersfield California as the time, date and place that the Commission shall consider protests to this reorganization proposal; and
- (e) the reason for the reorganization is to provide service to the residents in the proposed annexation territory and to detach territory no longer being served by the City; to dissolve the California City Community Service District and to dissolve County Service Area No. 12.9
