
Dear Ms. Rollings-McDonald:




This letter of opposition is in response to the Notice of Filing of Proposed Change of Jurisdictional Boundaries dated June 6, 2008 for the reduction of the sphere of influence for the Yucaipa Valley Water District. The documents associated with LAFCO 3097 propose a sphere amendment that would decrease the sphere of the Yucaipa Valley Water District and expand the sphere of the Beaumont Cherry Valley Water District.

The existing territory involves approximately 24 acres which is currently undeveloped vacant property that according to the attached documentation "...is intended to remain in its present state". The justification for the proposed reduction to the Yucaipa Valley Water District's sphere is based on the need "...to maintain control of the groundwater quality of the [Beaumont Cherry Valley Water District's] existing wells, to provide wellhead protection, and manage the [Beaumont Cherry Valley Water District's] facilities more efficiently".

Based on the fact that the subject property is to remain in its presently vacant and undeveloped state, there is no justifiable correlation to support the stated purpose that the sphere change will have any impact on water quality, provide wellhead protection or make the management of the Beaumont Cherry Valley Water District's operations more efficient.

Therefore, the Yucaipa Valley Water District does not support the reduction of the sphere of influence as proposed by LAFCO 3097.
