**A RESOLUTION OF THE LOCAL AGENCY FORMATION
COMMISSION OF THE COUNTY OF SAN BERNARDINO,
STATE OF CALIFORNIA, AMENDING ITS
SALARY SCHEDULE**

On Wednesday, May 19, 2010, on motion of Commissioner _____, duly seconded by Commissioner _____, and carried, the following resolution is adopted:

SECTION 1. The Local Agency Formation Commission for the County of San Bernardino, State of California, hereby finds and determines that it wishes to amend its Salary Schedule for LAFCO Employees.

SECTION 2. The Local Agency Formation Commission for the County of San Bernardino hereby resolves and orders that the LAFCO Salary Schedule is amended, as shown on the attached Exhibit A, as follows:

Salary Schedule:

Pursuant to the provisions of Section 202 of the LAFCO Human Resources Policies and Procedures, the cost of living salary adjustments for SB LAFCO employees previously approved and scheduled to be effective June 19, 2010 (3.25% across the board increase) and June 17, 2011 (2.75% across the board increase) are rescinded.

SECTION 3. The Executive Officer of the Local Agency Formation Commission is ordered to certify to the passage of this resolution and to cause a certified copy to be forwarded to the County Administrative Office, County Auditor-Controller/Recorder/Treasurer/Tax Collector and Manager of the County of San Bernardino's Employee Management and Compensation System (EMACS).
