Total acreage for City of Barstow: 26,293.92
Total acreage for Barstow FPD: 29,188.27
Barstow FPD acreage within the City of Barstow: 22,236.66
Percent of Barstow FPD acreage within City of Barstow: 76.18%

These land area estimates are based on automated, GIS data maintained by the County's Information Services Dept. This data is not of survey quality and is intended only to be a reasonable representation of the city and fire protection district boundaries as depicted on the State of California, Board of Equalization, Tax Rate Area maps. 
