
Ms. Chamberlin:

The voter verification for LAFCO 3000A shows that 60,798 registered voters live within the area specified. Out of the 60,798 registered voters, 53,731 live within the boundaries of the City of Fontana, and 7,067 live in the unincorporated areas near the City of Fontana. Thus, 88.38% of the registered voters live within the City of Fontana.

$$(53,731 / 60,798) \times 100 = 88.3762624$$
