


8. Consideration of: (1) CEQA Statutory Exemption for LAFCO 3107 – Service Review and Sphere of Influence Update for Crestline-Lake Arrowhead Water Agency

The service review and sphere of influence update study area encompasses approximately 110 sq. miles generally bordered by a combination of section lines and parcel lines along Butler Peak and Slide Peak (Snow Valley Ski Resort area) on the east; a combination of section lines and parcel lines along Sugarpine Mountain, Monument, Marshall, Arrowhead, Mill and Keller Peaks (generally along Hwy 18 and Hwy 330) on the south; a combination of section lines and parcel lines generally along Cajon and Cleghorn Mountains on the west; and a combination of section lines and parcel lines along Silverwood Lake, Pilot Rock, Mt. Marie Louise, Deer Mountain, and Ingham Peak on the north. The area includes Silverwood Lake, Lake Gregory and Lake Arrowhead and includes the unincorporated communities of Cedarpines Park, Valley of Enchantment, Crest Forest, Crestline, Twin Peaks, Blue Jay, Crest Park, Rimforest, Deer Lodge Park, Grass Valley Lake, Cedar Glen, Skyforest, Enchanted Forest, Fredalba, Smiley Park, Running Springs, Green Valley Lake and Arrowbear.



9. Consideration of: (1) CEQA Statutory Exemption for LAFCO 3149; and (2) LAFCO 3149 – Service Review and Sphere of Influence Update for Rim of the World Recreation and Park District


The service review and sphere of influence update study area encompasses approximately 110 sq. miles generally bordered by section lines along Butler and Slide Peaks on the east; section lines along Government Peak, Long, Red Rock Wall, and Panorama Points (generally along Hwy 18 and Hwy 330) on the south; a combination of section lines and parcel lines generally along Monument Peak and Breezy Point on the west; and section lines along Mt. Marie Louise, Deer Mountain, Little Shay Mountain and Hawes Peak on the north. The area includes Lake Gregory, Lake Arrowhead, including the unincorporated communities of Crestline, Twin Peaks, Blue Jay, Crest Park, Rimforest, Deer Lodge Park, Grass Valley Lake, Cedar Glen, Skyforest, Enchanted Forest, Fredalba, Smiley Park, Running Springs, Green Valley Lake, and Arrowbear Lake.



10. Consideration of: (1) Service Review for County Service Area 70 Improvement Zone D-1 (Lake Arrowhead Dam); and (2) Consideration of (a) CEQA Statutory Exemption for LAFCO 3144; and (b) LAFCO 3144 – Activation of Flood Control and Park and Recreation Powers for Lake Arrowhead Community Services District

The Lake Arrowhead Community Services District (LACSD) is proposing to activate its latent park and recreation and flood control powers as defined in Govt. Code Section 61100 (e), (f) and (r). The LACSD, which encompasses approximately 13 square miles, is generally bordered by a combination of section lines and parcel lines along Tunnel Two Ridge and Mount Marie Louise on the west, a combination of section lines and parcel lines (north and south of State Route 173) on the north, section lines and parcel lines along Mount Sorenson on the east, and parcel lines (north and south of State Route 18) on the south. The district serves the communities of Lake Arrowhead, Cedar Glen, Grass Valley, Twin Peaks, Crest Park, Rim Forest, Skyforest, Deer Lodge Park and Blue Jay.
