

The study area for LAFCO 3106 (San Bernardino Mountains Community Healthcare District) encompasses the communities of Crest Forest, Lake Arrowhead, and Hilltop, as defined by the Commission. The existing sphere of influence for the San Bernardino Mountains Community Healthcare District encompasses approximately 55 sq. miles generally bordered by section lines along the Snow Valley Ski Resort area on the east, section lines generally along Hwy 18 and Hwy 330 on the south, section lines generally along Strawberry Peak and Saddle Flats on the west; and section lines along Mt. Marie Louise and Crab Flats on the north. The area includes Lake Arrowhead including the unincorporated communities of Twin Peaks, Blue Jay, Crest Park, Rimforest, Deer Lodge Park, Grass Valley Lake, Cedar Glen, Skyforest, Enchanted Forest, Fredalba, Smiley Park, Running Springs, Green Valley Lake, and Arrowbear.

The study area for LAFCO 3136 (Bear Valley Community Healthcare District) encompasses the community of Bear Valley, as defined by the Commission. The existing sphere of influence for the Bear Valley Community Healthcare District encompasses approximately 128 sq. miles generally bordered by section lines along Round Mountain, Granite Peak and Onyx Summit on the east, section lines generally along Sugarloaf Mountain and Snow Summit on the south, section lines generally along Slide and Butler Peak on the west, and section lines along White Mountain and Silver Peak on the north. The area includes Big Bear Lake itself, the City of Big Bear Lake, and the unincorporated communities of Big Bear City, Fawnskin, Sugarloaf, Moonridge, Baldwin Lake and Erwin Lake.

Sphere of influence amendments for Commission review are being proposed for the San Bernardino Mountains Community Healthcare District (expansions/reductions) to encompass the Crest Forest, Lake Arrowhead, and Hilltop communities, as defined by the Commission, and for the Bear Valley Community Healthcare District (reductions) to encompass the Bear Valley community, as defined by the Commission.




8. Definition of Community and Service Review for Homestead Valley which includes the review of County Service Area 70 Zones R-15, R-20, TV-5 and W-1; and,

Consideration of: (1) CEQA Statutory Exemption for LAFCO 3148; and (2) LAFCO 3148 - Service Review and Sphere of Influence Update for Bighorn Desert View Water Agency

The service review and sphere area is located in the south desert region of the County and is generally bordered by a combination of the Bighorn Mountain Wilderness Area, half-section lines, and the western line of Range 5 East of Townships 1, 2, and 3 on the west; the Johnson Valley Off Highway Vehicle Area on the north; a combination of the Twentynine Palms Marine Corps Base, County Service Area 70 Improvement Zone W-1 (Goat Mountain), and the Hi-Desert Water District on the east; and a combination of the Bighorn Mountain Wilderness Area and Hi-Desert Water District boundary and sphere on the south. The boundary and/or sphere of influence include the communities of Johnson Valley, Homestead Valley, Landers, and Flamingo Heights.

The study area and sphere of influence amendments for Commission review include modifications to the Agency's sphere of influence (expanding the Agency's sphere of influence by approximately 11,128 acres and reducing its existing sphere of influence by approximately 13,754 acres) as shown on the map below.
